- 5. Notwithstanding The Company providing a risk assessment for each event it provides its services for, it is the responsibility of The Organiser to ensure that all necessary safety precautions are taken. The Company shall have no liability for claims arising in consequence of any injury or damage to persons or property unless caused by an act or omission of The Company.

Sale of Goods: Application and entire agreement

- These terms and conditions (the "Terms and Conditions") will apply to the purchase of the goods detailed in The Company's quotation or sales order ("Goods") by the "Organiser". In these Terms and Conditions, Pains Fireworks Ltd shall be referred to as "The Company", registered in England and Wales under number 01467177, whose registered office is at Common Farm Cottage, The Common, Damerham, SP6 3HR.
- 2. The person or company agreeing/signing this document is therefore confirming to purchase equipment, products or services from The Company. The power to make, vary, ratify or discharge this contract may be exercised by an individual acting with a limited company's express or implied authority and on behalf of The Company, but this must be clearly stated. The individual confirming this order and signing these Terms and Conditions directly and expressly warrants that he/she has been given and has received and accepted authority to sign and execute the documents and confirm orders on behalf of the party for whom it is indicated he/she has signed, and further has been expressly given and received and accepted authority to enter into a binding agreement on behalf of such party with respect to the matters concerned herein and as stated herein.
- 3. These Terms and Conditions will be deemed to have been accepted by the Organiser when you accept them or the quotation or from the date of any delivery of the Goods (whichever happens earlier) and will constitute the entire agreement between The Company and the Organiser.
- 4. These Terms and Conditions and the quotation (together, the Contract) apply to the purchase and sale of any Goods between the parties, to the exclusion of any other terms that The Organiser tries to impose or incorporate, or which are implied by trade, custom, practice or course of dealing.

The placing of a purchase confirms acceptance of these Terms and Conditions.

Interpretation

- 5. A "business day" means any day other than a Saturday, Sunday or bank holiday in England and Wales.
- 6. The headings in these Terms and Conditions are for convenience only and will not affect their interpretation.
- 7. Words imparting the singular number include the plural and vice-versa.

Goods

- 8. The description of the Goods is set out in The Company's sales documentation, unless expressly changed in The Company's quotation. In accepting the quotation, The Organiser acknowledges that they have not relied upon any statement, promise or other representations about the Goods by The Company. Descriptions of the Goods set out in The Company's sales documentati on are intended as a guide only.
- 9. The Company can make any changes to the specification of the Goods which are required to conform to any applicable safety or other statutory or regulatory requirements.

Price

- 10. All price lists, brochures and other information The Company provides with The Company's quotations (the "Price") are presented by The Company as accurately as possible. They are only binding to The Company if The Company has expressly confirmed them in writing.
- The Price of the Goods is set out in The Company's quotation or price list current at the date of The Organiser's order or such other price as The Company may agree in writing.
 If the cost of the Goods to The Company increases due to any factor beyond The Company's control including, but not limited to, material costs, labour costs, alteration of exchange rates or duties, or changes to delivery rates, The Company shall only increase the Price prior to delivery if notified to the Organiser with reasonable notice and if the Organiser consents to such increase. If the Organiser does not consent to such increase, the Organiser shall be entitled to terminate the specific purchase order with immediate effect.
- 13. The Organiser may be entitled to discounts. Any and all discounts will be at The Company's discretion.
- 14. The Price is exclusive of any applicable VAT and other taxes or levies which are imposed or charged by any competent authority.

Cancellation and alteration

- 15. Details of the Goods as described in the clause above and set out in The Company's sales documentation are subject to alteration without notice in regard to future purchase orders and are not a contractual offer to sell the Goods which is capable of acceptance.
- 16. If during the execution of the Contract it becomes apparent that it is necessary to make amendments or additions to the Contract so that it can be correctly executed, the parties shall adapt or amend the Contract under consultation. If the addition or amendment affects the time of implementation, we shall inform the other party as such as soon as possible.
- 17. The Company is not obliged to carry out a change to the order until The Company has confirmed that change in writing, and the other party will reimburse all reasonable additional costs that The Company incurs as a result of that change.
- 18. Quotations (including any non-standard price negotiated in accordance with the clause on Price) is valid for a period of 30 days only from the date shown in it unless expressly withdrawn by The Company at an earlier time.

Payment

- 19. The Company will invoice The Organiser for the Price either:
 - a. on or at any time after the acceptance of the quote/receipt of order; or
 - b. on or at any time after delivery of the Goods; or
 - c. where the Goods are to be collected by the Organiser or where the Organiser wrongfully does not take delivery of the Goods, at any time after The Company has notified the Organiser that the Goods are ready for collection or The Company has tried to deliver them.
- 20. The Organiser must pay the Price within 30 days of the date of The Company's invoice or otherwise according to any credit terms agreed between the parties.
- 21. New customers, or those not on account must pay the Price before the order will be dispatched
- 22. You must make payment even if delivery has not taken place and / or that the title in the Goods has not passed to the Buyer.
- 23. If The Organiser does not pay within the period set out above, The Company shall notify the Organiser of such lack of payment and provide the Organiser with 7 additional days to pay the outstanding amount, following which The Company may suspend any further deliveries to the Organiser and without limiting any of The Company's other rights or remedies for statutory interest, charge the Organiser interest at the rate of 4% per annum above the base rate of the Bank of England from time to time on the amount outstanding until the Organiser pays in full.
- 24. Time for payment will be of the essence of the Contract between the Company and you.
- 25. All payments must be made in Pound Sterling.
- 26. Both parties must pay all amounts due under these Terms and Conditions in full without any deduction or withholding except as required by law and neither party is entitled to assert any credit, set-off or counterclaim against the other in order to justify withholding payment of any such amount in whole or in part.

Delivery

- 27. The Company will arrange for the delivery of the Goods to the address specified in the quotation, or on the order or to another location the partiesagree in writing.
- 28. If The Organiser does not specify a delivery address or if both parties agree, The Organiser must collect the Goods from The Company's premises.
- 29. Subject to the specific terms of any special delivery service, delivery can take place at any time of the day and must be accepted at any time between 8 am to 8 pm.
- 30. If The Organiser does not take delivery of the Goods The Company may and without prejudice to any other rights:
- a. store the Goods and will charge The Organiser for all reasonable associated costs and expenses including, but not limited to, transportation, storage and insurance; and / or
- b. make arrangements for the redelivery of the Goods and will charge The Organiser for the costs of such redelivery; and/or
- c. after 10 business days, resell the Goods.
- 31. If redelivery is not possible as set out above, the Organiser must collect the Goods from The Company's premises and will be notified of this.
- 32. Any dates quoted for delivery are approximate only, and the time of delivery is not of the essence. The Company will not be liable for any delay in delivery of the Goods that is caused by a circumstance beyond The Company's control or The Buyer's failure to provide The Company with adequate delivery instructions or any other instructions that are relevant to the supply of the Goods.
- 33. The Company can deliver the Goods by instalments, which will be invoiced and paid for separately. Each instalment is a separate contract. Any delay in delivery or defect in an instalment will not entitle The Organiser to cancel any other instalment.

- 34. The Organiser must inspect the Goods on delivery or collection.
- 35. If The Organiser identifies any damages or shortages, the Organiser must inform The Company in writing within 7 days of delivery, providing details.
- 36. Other than by agreement, The Company will only accept returned Goods if The Company is satisfied that those Goods are defective and if required, have carried out an inspection.
- 37. Subject to The Organiser's compliance with this clause and/or the parties' agreement, the Organiser may return the Goods and The Company will, as appropriate, repair, or replace, or refund the Goods or part of them.
- 38. The Company will be under no liability or further obligation in relation to the Goods if The Organiser:
 - a. fails to provide notice as set above; and/or
 - b. makes any further use of such Goods after giving notice under the clause above relating to damages and shortages; and/or
 - the defect arises because The Organiser did not follow The Company's oral or written instructions about the storage, installation, use and maintenance of the Goods; and/or c.
 - d. the defect arises from normal wear and tear of the Goods; and/or
 - the defect arises from misuse or alteration of the Goods, negligence, wilful damage or any other act by The Organiser, their employees or agents. e.
- 39. The Company will bear the risk and cost of returning the Goods.
- 40. Acceptance of the Goods will be deemed to be upon inspection of them by The Organiser and in any event within 7 days after delivery.
- 41. Upon The Organiser's receipt of the Goods, the Organiser has a period of 14 days to cancel the order and return the items in the same condition to which The Organiser received them. If The Company is notified of The Organiser; cancellation after 14 days from the date of delivery, the return will not be accepted.

Risk and title

- 42. The risk in the Goods will pass to The Organiser on completion or delivery.
- 43. Title to the Goods will not pass to The Organiser until The Company has received payment in full (in cash or cleared funds) for: (a) the Goods and/or (b) any other goods or services that The Company has supplied in respect of which payment has become due.
- 44. The Company is liable for all losses (including losses resulting from theft, loss or usage) caused to The Company's goods in the period preceding the transfer of ownership. Damage, theft or loss must be reported to The Company without delay.
- 45. The Company reserves the right to keep goods that The Company has in its possession until all payment obligations are made to us, irrespective of the orders placed for the aforementioned or other goods of the Buyer. We also have the right of retention in the event of the Buyer being declared bankrupt. 46. Until title to the Goods has passed and considering the Goods that are in The Organiser's possession, The Organiser must (a) hold the Goods on a fiduciary basis as The Company's

Termination

48. Both parties can terminate the sale of Goods under the Contract where:

- Either party commits a material breach of the obligations under these Terms and Conditions; a.
- b. Either party is or becomes or, in the other party's reasonable opinion, is about to become the subject of a bankruptcy order or take advantage of any other statutory provision for the relief of insolvent debtors;
- Either party enters into a voluntary arrangement under Part 1 of the Insolvency Act 1986, or any other scheme or arrangement is made with such party's creditors; or
- d. Either party convenes any meeting of their creditors, enter into voluntary or compulsory liquidation, have a receiver, manager, administrator or administrative receiver appointed in respect of its assets or undertakings or any part thereof, any documents are filed with the court for the appointment of an administrator, notice of intention to appoint an administrator is given by such party or any of such party's directors or by a qualifying floating charge holder (as defined in para. 14 of Schedule B1 of the Insolvency Act 1986), a resolution is passed, or petition presented to any court for the winding up of your affairs or for the granting of an administration order, or any proceedings are commenced relating to your insolvency or possible insolvency.

Limitation of liability

- 51. We accept no responsibility for equipment that does not work in conjunction with equipment supplied by the Buyer.
- 52. If we do not deliver the Goods, our liability is limited, subject to the clause below, to the costs and expenses incurred by the Buyer in obtaining replacement goods of similar description and quality in the cheapest market available, less the price of the Goods.
- 53. total liability will not, in any circumstances, exceed the total amount of the Price payable by you.
- 54. Neither party will be liable (whether caused such party's employees, agents or otherwise) in connection with the Goods, for:
 - a. any indirect, special or consequential loss, damage, costs or expense; and/or
 - b. any loss of profits; loss of anticipated profits; loss of business; loss of data; loss of reputation or goodwill; business interruption; or, other third party claims; and/or
 - c. any failure to perform any of its obligations if such delay or failure is due to any cause beyond itsreasonable control; and/or
 - d. any losses caused directly or indirectly by any failure or breach by you in relation to the other party's obligations.
 - any loss relating to the choice of the Goods and how they will meet your purpose or the use by you of the Goods supplied. e.
- 55. The exclusions of liability contained within this clause will not exclude or limit either party'sliability for death or personal injury caused by such party's negligence; or for any matter for which it would be illegal for that party to exclude or limit its liability; and for fraud or fraudulent misrepresentation.

Communications

56. All notices under these Terms and Conditions must be in writing and signed by, or on behalf of, the party giving notice (or a duly authorised officer of that party).

- 57. Notices will be deemed to have been duly given:
 - when delivered, if delivered by courier or other messenger (including registered mail) during the normal business hours of the recipient;
 - b. when sent, if transmitted by email and a successful transmission report or return receipt is generated;
 - c. on the fifth business day following mailing, if mailed by national ordinary mail; or
 - on the tenth business day following mailing, if mailed by airmail.
- 58. All notices under these Terms and Conditions must be addressed to the most recent address or email address notified to the other party.

Data protection

- 59. When providing the Goods to The Organiser, The Company may gain access to and/or acquire the ability to transfer, store or process personal data of employees of the Organiser.
- 60. The parties agree that where such processing of personal data takes place, The Organiser shall be 'data controller' and The Company shall be the 'data processor' as defined in the General Data Protection Regulation (GDPR) as may be amended, extended and/or re-enacted from time to time.
- 61. For the avoidance of doubt, 'Personal Data', 'Processing', 'Data Controller', 'Data Processor' and 'Data Subject' shall have the same meaning as in the GDPR.
- 62. The Company shall only Process Personal Data to the extent reasonably required to enable it to provide the Goods as mentioned in these terms and conditions or as requested by and agreed with The Organiser, shall not retain any Personal Data longer than necessary for the Processing and refrain from Processing any Personal Data for its own or for any third party's purposes.
- 63. The Company shall not disclose Personal Data to any third parties other than employees, directors, agents, subcontractors or advisors on a strict "need-to-know" basis and only under the same (or more extensive) conditions as set out in these Terms and Conditions or to the extent required by applicable legislation and/or regulations.
- 64. The Company shall implement and maintain technical and organisational security measures as are required to protect Personal Data Processed by the Company on behalf of the Organiser. Further information about the Company's approach to data protection are specified in its Data Protection Policy, which can be obtained by contacting the Data Protection Officer. 67. Neither party shall be liable for any failure or delay in performing their obligations where such failure or delay results from any cause that is beyond the reasonable control of that party. Such causes include, but are not limited to: power failure, internet service provider failure, industrial action, civil unrest, fire, flood, storms, earthquakes, acts of terrorism, acts of war, governmental action or any other event that is beyond the control of the party in question. In the event of this, such partyshall make a charge of the reasonable costs incurred.

No Waiver

68. No waiver by either party of any breach of these Terms and Conditions shall be considered as a waiver of any subsequent breach of the same or any other provision.

Severance

Law and jurisdiction
